**WEDNESDAY, JUNE 17, 2026**

**A. CALL TO ORDER**

Committee Chair Hejny called a meeting of the Ennis Charter Committee to order Wednesday, June 17, 2026, at 5:00 P.M. in the Ennis City Hall Commission Chambers, 107 N Sherman, Ennis, Texas 75119.

**B. CITIZEN PUBLIC COMMENTS**

**C. ITEMS FOR DISCUSSION AND INDIVIDUAL CONSIDERATION**

**C.1. Consider approval of the Minutes for the Charter Review Committee meeting held May 27, 2026.**

Committee Chair Hejny read the item. Member Falkenbach made a motion, seconded by member Hull, to approve the item as read. A vote was cast, 4 in favor, 0 against. Motion passed.

**C.2. Consider approval of the Minutes for the Charter Review Committee meeting held June 03, 2026.**

Committee Chair Hejny read the item. Member Falkenbach made a motion, seconded by member Morales, to approve the item as read. A vote was cast, 4 in favor, 0 against. Motion passed.

**C.3. Consider approval of the proposed changes to the Home Rule Charter Article 5, Article 6, Article 7, and Article 8.**

Committee Chair Hejny read the item and suggested the Committee review the proposed changes:

- Member Falkenbach made a motion, seconded by Member Hull, to approve the proposed amendments to Section 5.01.01 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.
- Member Morales made a motion, seconded by Member Hull, to approve the proposed amendments to Section 5.03 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.
- Member Hull made a motion, seconded by Member Falkenbach, to approve the proposed amendments to Section 5.08 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.

- Member Falkenbach made a motion, seconded by Member Morales, to approve the proposed amendments to Section 6.01 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.
- Member Falkenbach made a motion, seconded by Member Hull, to approve the proposed amendments to Section 6.02 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.
- Member Falkenbach made a motion, seconded by Member Morales, to approve the proposed amendments to Section 7.10, with the addition of changing references to ‘policeman’ to ‘police officer’. A vote was cast, 4 in favor, 0 against. Motion passed.
- Member Morales made a motion, seconded by Member Falkenbach, to approve the proposed amendments to Section 8.05 as presented. A vote was cast, 4 in favor, 0 against. Motion passed.

**C.4. Discuss proposed changes to the Home Rule Charter Article 9, Article 10, Article 11, and Article 12.**

Committee Chair Hejny read the item. Discussion included Section 10.01 Eminent Domain, City Attorney to provide general language in compliance with state law; Section 11.06 regarding three required readings; City Attorney to review Section 11.08; change language in Section 11.09 from ‘telegraph, telephone and electric wires’ to ‘all utilities’; better language in Section 12.02; Section 12.04 suggest changing ‘30 days’ to ‘90 days’; City Attorney provide more appropriate language for entirety of Section 12.07; and remove Section 12.08 and replace with ‘Non Substantive Revisions’ prepared by the City Attorney.

**C.5. Review Charter Committee Schedule of remaining meetings.**

No changes were suggested to the calendar of meetings. Next meeting scheduled for July 1, 2026. The Committee will review the final proposed amendments on July 15<sup>th</sup> and present them to the City Commission for consideration on July 21<sup>st</sup>. The City Commission will consider ordering a Special Election on August 11<sup>th</sup>.
