Mr. Hoffman

Extra doors coming in: Loading dock door at Bradley Monday and DMS Tuesday.

Two sets of exterior doors for Irving.

April 15 to 20th waste dump at Irving

Woodshop doors DHS next week – fire doors to exit.

Mr. Marcucio: New doors will be on the inside.

Mr. Hoffman: Correct.

DHS – Gazebo is ordered and we are working with the fire department. It is located off of the cafeteria.

Dr. Conway: This is part of the Voices for Change grant students proposed last year.

Mr. Kurtyka: Fire alarm went in the other day.

Mr. Hoffman: Electricians replaced the lighting controls in the basement. They don't know what caused it, but it is back online and everything is normal. We did replace two breakers and about 20 feet of wiring today.

Mr. Marcucio: How long were students and staff outside?

Dr. Conway: At least 30 minutes outside in the parking lot. It was a beautiful day and things moved along quickly.

Upcoming Projects

Mr. Hoffman: Irving lower-level flooring between the 15th and the 20th also.

Bradley, upcoming, going to get pricing now. Replacing the ceiling tiles in the kitchen.

Emergency lighting repairs in Derby Middle School.

Irving School upcoming, relocating the flagpole. The flag is down right now at Irving School because of the Memorial tree.

Monday, we are going to have the electricians test all the lighting at Derby Middle School.

There's a cylinder where the drain is and you have to change each month. There's a chemical inside of this cartridge. No gas comes out, liquids will go down. No odors as long as you change the cartridges every six months.

Mr. Trainor: At the beginning of this week, we had asbestos walk through.

Mr. Hoffman: We had the periodic asbestos inspection. We completed Central Office. Both Elementary Schools and DHS. TRC. I have not got reports back on that yet. Once I get the reports back, I'll update you on that. TRC will submit those by Tuesday.

Solar Panel Update

Mr. Kurtyka: I talked to Mr. Hoffman before the meeting.

Mr. Hoffman: Solar panels at DMS, that project had resumed. We finally got approved for the conduit. They've been running every day. Finishing up all conduit at the High School. But they are back on site working.

All of the solar panels are already in place at the High School.

Dr. Conway: Some of the wiring does come in. They had to run under the driveway but not panels.

Mr. Hoffman: As far as Bradley solar panels, vans are still waiting for approval of the change order for the switch gear room. That's coming from the City. The UI approved the plans.

Dr. Conway: But the panels themselves are on the roof. They're just not operable. They're not hooked up. They finally selected a plan, now they're moving forward installing a unit in front of a school.

Mr. Hoffman: They have to replace the transformers inside the school. The only school up and running is Irving. Irving is up and live. We're running on solar at Irving. They switched it over this past summer.

Dr. Conway: Can we do a comparison then of kilowatt powers to say last year same time and this year?

Mr. Hoffman: Yes. I will be onsite when they seal up.

Capital Plan List and Status

Mr. Marcucio: Is that you, Robbie?

Mr. Trainor: Yes. So, this is the list we submitted to the City in August. This is what we were hoping to have approved.

There are grants available. The HVAC grant that we just applied for, we went over last Board meeting through Johnson Controls for Bradley and the High School. Total is around 14 million. It's just a waiting game now. I believe it's around 14 million for both schools. If we get this, we will be reimbursed. Is that 76 percent, the reimbursement.

Dr. Conway: Correct. This particular one is up to 95 percent.

Mr. Trainor: Yes. JCI is 95 percent.

Dr. Conway: The State had a similar program for Districts. A 50 million set aside for a District to apply for. Subsequent to that a Federal one came out, which is a 95 percent reimbursement. And the remaining five percent can be amortized over 20 years in a loan. We went back to the City with that particular grant project. Submitted the preliminary application on January 26th and we're waiting to hear back whether we meet eligibility for the next stage. We won't know until the end of March.

Remaining items again, I don't believe the Capital Planning Committee has met since we submitted this plan in August.

Mr. Trainor: The Capital Committee hasn't met yet. We are going to be applying for a security grant. The SS is just strictly education. Updating security cameras.

Dr. Conway: Asked them to give us a quote on cameras in the site line of the perimeter as well.

Mr. Trainor: One of the nice things about these cameras is we will have license plate readers. List of approved license plates. It will also be connected to police as well. It's software upgrades for the cameras.

Dr. Conway: Part of A Plus. All of the cameras will be updated with that.

Mr. Trainor: You can track everyone's movement as long as they're in the building.

Either the needs assessment was not provided, or it did not adequately describe the age of the building, the date of the last major renovation, the last capital expenditure, and any significant deferred maintenance need. The paper does not articulate significant energy cost savings as a result of the proposed improvement(s). Please reference the anticipated percentage energy cost savings. The paper does not adequately explain the innovation and/or scalability of the proposed project.

While the paper articulates a general fiscal need, details have not been provided to explain the specific capital needs .
