“Supplemental Motor Vehicle Tax Bill Collection Due Dates”

Be it hereby resolved by the Board of Aldermen/Alderwomen that, effective upon passage and pursuant to Connecticut Public Act 24-208, the following is approved regarding the collection due date of supplemental Motor Vehicle Taxes:

- Any vehicle registered between October 2 and March 31 annually will have a bill due on July 1 in the same year following the March 31 deadline.
- Any vehicle registered between April 1 and September 30 annually will have a bill due on January 1 of the following year, directly after September 30.

Background

Public Act No. 24-208

The Connecticut General Assembly has passed legislation that affects motor vehicle supplemental tax billing, primarily through Public Act No. 24-208. The bill grants municipalities flexibility to set their own due dates for Motor Vehicle Supplemental Tax bills. The Tax Collector recommends changing the previous annual due date of January 1 to:

- Any vehicle registered between October 2 and March 31 annually will have a bill due on July 1 in the same year following the March 31 deadline.
- Any vehicle registered between April 1 and September 30 annually will have a bill due on January 1 of the following year, directly after September 30.

This change will help keep the collections more aligned with the regular Motor Vehicle billing cycle. It will also save money through club billing which combines bills to the same person in 1 envelope.

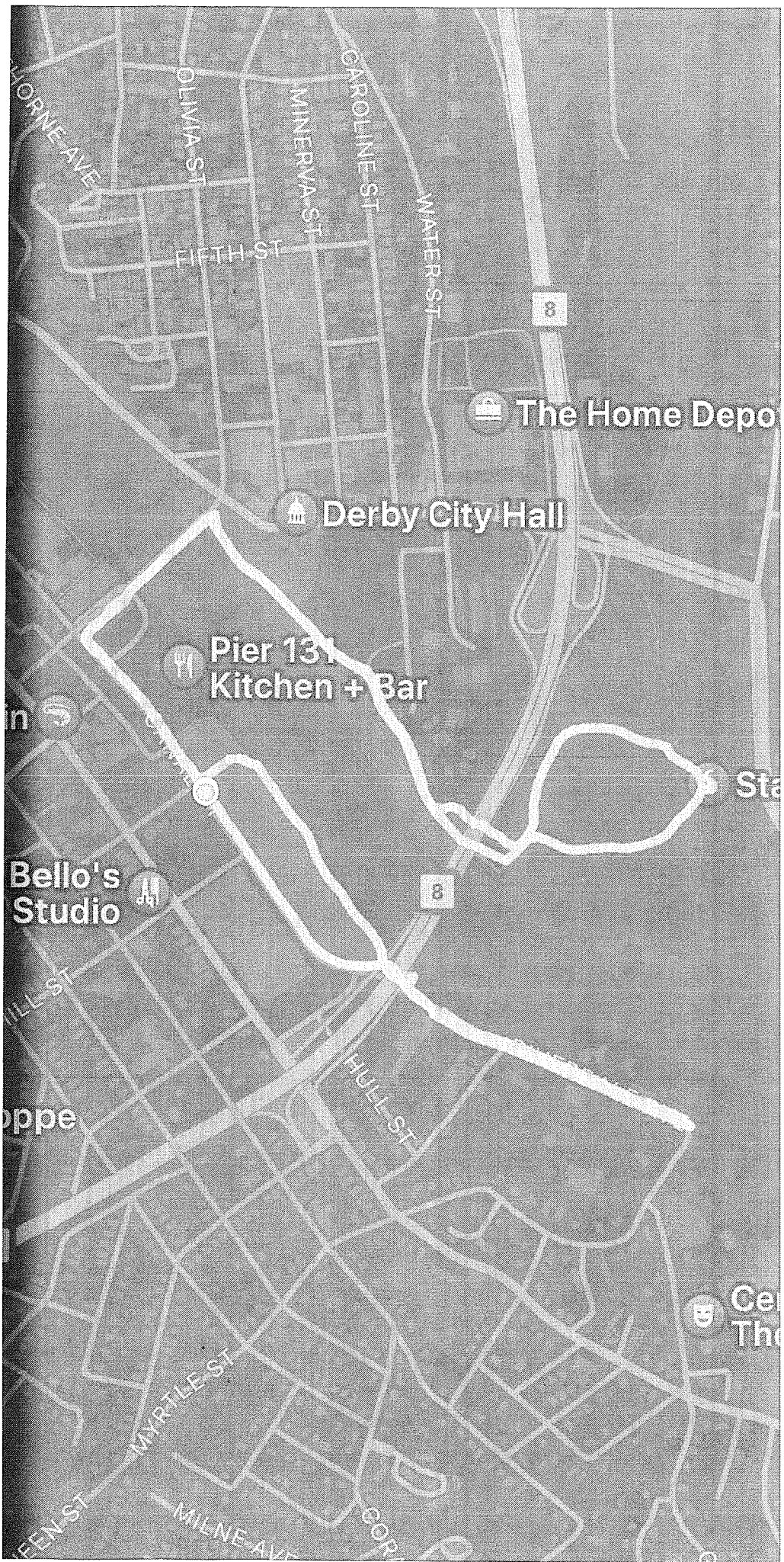

This is a proposal for the revival of the Derby Ansonia Beltline Trolley Trail. Please see this link from 2009 for information about the earlier version of the trail:

One of the routes of Derby's historic trolleys was a 4.1 mile loop, the Beltline, running between Derby and Ansonia, carrying people and serving as vital freight transportation of manufactured goods to the railroads and navigable river. The loop ran from the trolley barns (current location of Trolley Pointe apartments) west on Main Street, north on Elizabeth, Seymour, and Atwater, then into Ansonia on

Clifton and Bridge Streets, onto Ansonia's Main Street, back into Derby on Derby Ave, and finally turned back onto Derby's Main Street.

Our proposal is to mark the sidewalks of this trolley route, starting at the eastern corner of the entrance drive into Home Depot and the Derby/Shelton train station, with stencils of trolley cars, in order to allow for educational walking tours, either with a human guide or with a printable sheet of pertinent information. The stencils were already created for the 2009 project and have been provided to us by the Derby DPW. The color of the trolleys will be matte charcoal grey on white concrete pavement and matte white on darker asphalt pavement. The stencils will be marked in Derby with the words 'Derby Beltline' in gloss red paint and in Ansonia with 'Ansonia Beltline' in gloss blue paint. This project could also serve as a public service project for a Derby High School student. Currently, DHS senior Gianna Akter is assisting with all aspects of the process.

In the original proposal link, the trolley stencils are described as placed at 0.1 mile intervals. We propose rather that the trolley stencils will not mark distance, but be placed in order to serve as directional markers along the Beltline route. The trolleys will be placed and spaced for aesthetic viewing along the edges of the sidewalks of the routes, marking corners where walkers would turn, and with a slightly higher density of stencils downtown (along the north side of Main Street and the Elizabeth Street sidewalk alongside the Green) and lower density along long straight stretches of the route (Atwater and Seymour and Derby Avenue). The lengthwise orientation of the trolleys will point in the direction of travel. A stenciled arrow might occasionally be utilized to clarify directions. Ideally, a walker could find their way along the route by following the stenciled direction markers, creating a fun experience for both adults and children, a local analogy to Boston's Freedom Trail. As this is a pedestrian route, trolley stencils will not be placed on the pavement of roadways, only on sidewalks.

We propose to mark the distance with black stenciled numbers indicating each tenth of a mile along the route, similar in size to the distance markers on the Derby Greenway. This would allow for walkers and runners to measure their mileage for fitness purposes. Where the exact 0.1 mile segment falls in a roadway, we would propose, for accuracy, to mark that exact spot in the road (the numbers are not large nor of bright color).

On Saturday and Sunday, June 8-9, the Connecticut Forest and Park Association (CFPA) is celebrating Connecticut Trails Day, an annual event with over 200 free guided hikes and walks all over the state. For Trails Day, we are conducting a guided walking tour of the Beltline route on Sunday, June 8. See link:

We request permission to mark the Derby portion of the Beltline with trolley stencils, distance marker stencils, and arrow stencils, as appropriate. This same proposal will be made to the City of Ansonia, for the Ansonia portions of the loop.

Ideally, we would like to have the Derby stencils in place, using permanent spray paint, prior to the June 8 Trails Day walk.

Ansonia has not yet given permission, but is allowing for temporary marking of the route with spray chalk.
