## **FACILITIES DEPARTMENT REPORT**

Mr. Hoffman: Bradley School, updating the Committee on the heating system.

Irving School, updating the Committee on the plumbing repairs. Replaced the steel.

Mr. Foley: I would wait for that steel, copper. It doesn't make sense.

Mr. Hoffman: It doesn't. But we replaced copper.

Derby Middle School, chiller going pretty well. We're still running it about 3 hours a day during the afternoon, the turbines.

Mr. Foley: Are we regulating the rooms on the top floor. Are they being regulated now or are we still receiving complaints about that.

Mr. Hoffman: Everything right now is being regulated.

Mr. Foley: This was the chiller that had it.

Mr. Hoffman: No, this is the temp chiller.

Mr. Foley: Okay.

Mr. Hoffman: DMS, middle school. They're working on it. 10/27 they'll be here to install it. We had a semi-annual fire drill inspection on the 13<sup>th</sup>. No issues reported. Over at the high school, in 104, blower motor went on that unit. A new blower motor is about \$1,300. Cost about \$1,400 to replace new units.

Mr. Foley: What does that motor do?

Mr. Hoffman: That motor just heats one room in the high school. It's not room 104 anymore. Its G06 had bigger issues.

Mr. Foley: G06 is in the basement, isn't it?

Mr. Hoffman: Yeah.

Mr. Foley: We don't use that?

Mr. Hoffman: No. Main entrance doors over by the fishbowl. Replaced wiring. We had an issue where they were buzzing. Now they are operating independently. District wide fire marshal inspection. The violations are completed. We had the reinspection. The only things not completed are the fire doors at the high school. Going to cost roughly \$16,000. Our facilities management system, SMX, is up and running.

Mr. Foley: Did the swing come in at the Bradley School Playground?

Mr. Hoffman: Yes. The other part is coming in in two weeks.

Mr. Foley: I had it down that it was on the 29<sup>th</sup> of September.

Mr. Hoffman: Yes, that part did come in. We're still waiting on zip line and swing.

Mr. Foley: Thank you very much for your report. It was very comprehensive.

#### **PLANTS AND FACILITIES FINANCIAL REPORT**

Mr. Trainor: We're in a pretty good place. We've got a balance of 188,000. Still a few months left of this year. A couple things to note Bradley paid off this year. The City sent us the funds. Budgeted lines went over budget. And that's the third section of maintenance at Bradley. It looks like about 15,000 over. I just have to move the money over. I have not gotten to that yet.

Other big one repairs of the building at DMS, and this is all around the chiller system. Aside from that, the big issues last year were electricity because of that chiller. The electricity section is at the bottom of the first page. As where we are right now we are encumbered fully for all of those lines, so that final column on the right, you'll see all the zeroes. So, we are fully encumbered. And we're trending right now to be able to liquidate some of those encumbrances at the end of the year. We are watching this very closely so that we don't get into what happened last year with the electricity being so far over budget. So, that's kind of where we're at. Jim and his team have been phenomenal as always. He's keeping me up on what they need. What they're doing as opposed to outsourcing. So we are really, we hit the ground running this year. And really looking forward to see where we come out.

Mr. Foley: Robbie, are we locked in on oil delivery prices.

Mr. Hoffman: We don't use oil.

Mr. Foley: That's right, we're on natural gas.

Mr. Trainor: Yes, we are not on oil.

Mr. Trainor: That's the second from the bottom that section. It looks like Central Office is forecasted, encumbered being a little over budget. But in that third column, since the beginning of the year, we've only paid \$43 to natural gas to Central Office. So, my guess is we're over encumbered.

Mr. Foley: Okay. Ladies, any questions, Karla, Melissa.

Ms. Mongillo: I don't have anything. Thank you.

Mr. Foley: Karla.

Ms. Malerba: When you say ADA swings. Is that like a handicap kind of thing.

Mr. Hoffman: Yes, that's a handicap swing.

Ms. Malerba: Very good. No questions.

Mr. Foley: Robbie, thank you.

#### **DISCUSSION ON SIGNS REMOVED FROM THE FOOTBALL COMPLEX**

Mr. Foley: This was brought up to me at our coffee get together every week. Some gentleman wanted to know where the signs are. And I said I'd bring it up at this meeting. Doctor, can you give me any information on that?

Dr. Conway: Right now, it's just identifying the funding. I think it was around \$13,000 grand. City was going back to the State to double-check for any funding left in that account according to Mr. Hall. The State had to double-check and it did not appear to be funds left. Then it would be a matter of going to the BOAT Committee to request funding and the Board of Alderman to request funding was all for the project. Even Joan had to pitch in some additional funds, close to \$450,000. The State funds is all used up.

Mr. Foley: What signs were they talking about? I don't know what signs they were referring to.

Dr. Conway: The sign by the snack bars, the sign by the press box, lower left side of the field. Actually, there might have been two of them by the press box and then the DeFilippo field. Some of them were in place originally built that was removed during construction and stored. We have Signs Unlimited.

Mr. Foley: So, at this point it's up in the air, correct?
