A meeting of the Derby Board of Police Commissioners was held on May 12, 2025 at the Derby Police Department, 125 Water Street, Derby, CT.

The meeting was called to order at 6:05PM by Commissioner DeGennaro.

1. Pledge of Allegiance

2. Roll Call

Present were Commissioners DeGennaro and Gloade. Also present was Chief Todd.

3. Public Portion

No one from the public spoke.

4. Adoption of Agenda

Commissioner DeGennaro motioned to add discussion and possible action regarding extension of the no parking area on Factory Street from Main Street north for approximately 150 feet to the Traffic Authority Business. Commissioner Gloade seconded and the motion carried.

5. Acceptance of Previous Meeting's Minutes

Commissioner Gloade motioned to accept the 14 APR 25 minutes. Commissioner DeGennaro seconded and the motion carried.

6. Old Business

No old business to discuss.

7. New Business

Commissioner DeGennaro motioned to promote Sergeant Frank DeAngelo to Lieutenant and Patrolman Joshua Cash to Sergeant. Commissioner Gloade seconded and the motion carried.

8. Department Reports

Chief Todd reviewed the monthly patrol activity where there was nothing significant other than a potential increase in assault investigations. On other department updates, firearms qualifications with new firearms are being completed, the new UTV has been deployed to the greenway for the past month to 6 weeks, and two grievances from 2023 have been settled.

9. Communications

No communications to discuss.

10. Traffic Authority Business

Discussion on requests from the Derby 350th Anniversary Celebration Committee for the closure of Elizabeth Street from Fifth Street to Thompson Place and closure of Minerva Street from Fifth Street to Fourth Street on Friday May 30, 2025 at a time to be determined in the afternoon until Sunday June 1, 2025 at 11:00pm. Chief Todd recommended to approve with the caveat that the street is reopened when the event is over in the evening and then closed again.

The second request is for the closure of Elizabeth Street from Fifth Street to Thompson Place on Saturday August 30, 2025 at a time to be determined in the afternoon until midnight. Chief Todd recommended to approve.

Commissioner Gloade motioned to approve both requests for street closures on May 30th to June 1st and on August 30th. Commissioner DeGennaro seconded and the motion carried.

Chief Todd proposed moving the No Parking sign that used to be on Factory Street at the intersection with Main Street back approximately 150 feet towards Water Street. The previous sign was taken down when the sidewalk was redone and the shoulder eliminated to make two lanes, this is causing an issue when cars are parked on the straight lane making cars travel into the dedicated left turn only lane.

Commissioner Gloade motioned to approve a sign being placed 150 feet back from the road.

Commissioned DeGennaro seconded and the motion carried.

11. Adjournment

Commissioner DeGennaro motioned to adjourn at 6:16PM. Commissioner Gloade seconded and the motion carried.
